(7) Condor lighting cranes with generators in neighborhood streets. Atmospheric smoke and picture car burning with smoke effects. Car flipped over, no car stunts or flip-overs.

**Permittee shall comply with the following Conditions of Approval:**

- Film activity shall not start prior to contacting each shift Inspector.**
- Comply with all attachments listed:  
TCP PF25-0003 & PF25-0008 - Piru - HBO Latitude S1\_REV2.pdf
- For periods when equipment or other occupancy of half of the roadway is necessary for periods exceeding the 3 minute maximum ITC, traffic control shall be per CA MUTCD TA-10 with 2 CHP providing flagging. During periods when CA MUTCD TA-10 is in place, no other film activities that would require traffic control assistance shall occur as determined by the Inspector or the CHP.
- At a minimum, 2 CHP shall be required at all times.
- Parking and storage of all equipment and vehicles related to the filming, but not in current use, shall be located at the designated base camp location.
- Permit not valid without an approved base camp location outside the County road right-of-way.
- Filming or signage outside the right-of-way is not part of this permit.
- Filming between 10pm-7am:  
Lighting: will be directed to the road only and should not impact surroundings neighbors.  
Generators: Shall be studio generator, specifically for the entertainment industry, to reduce noise and mitigate noise levels which are not normal for the area."
- Contact the Inspector 1 hour prior to permit start time to specify first filming location and any deviation in arrival time.
- Stopping, standing, or parking is prohibited for film related vehicles between the southernmost driveway for the Piru Post Office and a point 60' northward along the east curb line of Main Street.
- Drone operations are not enforced by Ventura County. Any party interested in enforcement activity or investigating possible violations of the Section 333 Exclusion (FAA Certificate) must contact the Federal Aviation Administration Flight Standards Regional Office at (310) 725-3300.
- Stopping, standing, or parking is prohibited for film related vehicles between the southernmost driveway for the Piru Post Office and a point 60' northward along the east curb line of Main Street.

**STANDARD CONDITIONS**  
**COMMERCIAL MOTION OR STILL PICTURE PHOTOGRAPHY**

1. The Permittee shall not start filming prior to approval to proceed from the Ventura County Public Works Inspector (hereinafter "Inspector"). The Inspector will verify that the traffic control set-up, California Highway Patrol (hereinafter "CHP") provisions, and other requirements of the permit are met prior to giving approval to proceed.
2. The Permittee is required to make arrangements with the CHP liaison at (323) 860-2960 x103 or fax (323) 817-4113 for officers to be present during filming. No filming shall begin without the CHP present. Traffic control procedures shall be determined and approved by the Inspector.
3. A minimum of two CHP Officers are required on each road during periods of film activity. Two additional CHP Officers are required for each intersection at least 5 minutes in advance of film activity arrival for film activity where vehicles are in-motion.
4. The Permittee shall be responsible for providing, installing, and maintaining traffic signs in accordance with the traffic control plan and as directed by the Inspector. Filming shall not begin until the required signs are in place.
5. Permittee shall post "Special Event" or "Road Work" signs with date(s) on both ends of road limits on any and all road (s) where film activity is permitted, at least 24 hours prior to filming. Film activity with rolling traffic control above the legal minimum speed limit is exempt from this requirement.
6. Locations where full road closure has been authorized shall be posted with 4' x 4' minimum size notification signs at each end of the closure, or per the approved traffic control plan, at least 72 hours in advance of the closure.
7. For permits authorizing "No Parking" posting(s), Permittee shall furnish and post signs 12" x 18" minimum size, pre-printed for this purpose in permanent red ink, with date and time written in permanent, thick black marker at least 72 hours in advance of the allowed permit parking prohibition. Signs shall be posted along the roadway in front of every residence or business in the posting limits, but in no event shall the spacing of the signs exceed 250 feet. Permittee shall remove the signs immediately when the posting period has expired. No Parking zones are only granted for picture purposes only and do not provide a grant of exception for any film related vehicles or waiver of any other special condition or condition of approval.
8. Base camp, including catering trucks, restroom facilities, equipment trucks, props, personal vehicles, etc. shall be located on private property, not on the paved roadway or on the road shoulder.
9. Walkie-talkies, to be continually maintained in working condition, shall be provided by the Permittee to the Inspector, the Community Film Liaison, and each CHP Officer for use in traffic control.
10. The number of vehicles and personnel on County right of way shall be limited only to those immediately necessary for filming at the filming site and shall be parked off the traveled way, in a closure area, or as may otherwise be expressly allowed in the permit conditions of approval. In the event the parking or storage is outside the lane closure or full road closure area then a W21-5 SHOULDER WORK sign shall be used in addition to other traffic control devices required by the plan(s).

11. Vehicles not immediately necessary for filming at the filming site, including but not limited to those used to transport personnel and cameras, sound and lighting equipment and reflectors, shall be restricted to loading and such other limitations as may be deemed appropriate by the Inspector and CHP unless otherwise expressly allowed in the permit conditions of approval.

12. Simultaneous film activity, including prep or strike, is not permitted, unless otherwise expressly allowed in the permit conditions of approval.

13. Traffic delays shall be limited to less than three (3) minutes under the direction of the Inspector. The length of traffic delays may be further restricted at the discretion of the Inspector.

14. Over-width process trailers, camera trucks, towed vehicles, picture cars, etc. shall not extend over the road centerline, whether marked or unmarked. The use of over-size vehicles may be restricted as directed by the Inspector.

15. Sidewalks and areas of pedestrian activity shall have any trip hazards related to film equipment, such as cables and wires, protected from such hazards. Methods of protection shall meet all ADA requirements. Sidewalk closures are not allowed (other than intermittent pedestrian control), unless expressly allowed in the permit conditions of approval.

16. The Permittee shall keep pedestrians out of the traveled way and display courtesy to passing motorists.

17. The Permittee shall notify the Inspector prior to any pavement wet downs. The pavement wet-downs may be restricted as directed by the Inspector. "Wet Pavement Ahead" signs must be posted in each direction of travel, and only when pavement is wet.

18. The location of any condors and cranes are subject to the approval of the Inspector.

19. The Permittee shall provide for trash collection and removal.

20. The traveled way shall be swept clear of dirt and other debris resulting from the filming prior to releasing traffic.

21. Using or disturbing private property without prior consent of the property owner is prohibited.

22. Removal or covering of road signs, street name signs or disturbing in any way County property or road facilities without prior written permission of the County is prohibited. Removal and replacement of signs and posts is to be done in the presence of, and upon demonstrating prior written permission to, the Inspector.

23. Failure to comply with all permit conditions or to conduct all operations as directed by the Inspector shall result in a cancellation of this permit and immediate removal of all personnel and equipment from the County road right of way.

24. Requests for cancellations, rescheduling or modifications of the permitted filming hours, locations or other permit conditions, shall be made during office hours (7:30 am - 4:30 pm, Monday - Friday) by calling (805) 654-2055 24-hours in advance of the filming starting time. Failure to provide notification may result in permit cancellation and forfeiture of permit fees.
